# **2022 AUDIT PRESENTATION**

G. Emmerich, of Harrington, Langer and Associates, reviewed the 2022 North Metro Telecommunications Commission annual financial report. No abnormalities were found and the Commission is in a strong financial position.

# REPORT OF EXECUTIVE DIRECTOR

H. Arnson reported on the following items:

- North Metro TV staff has been working with the Minnesota Office of Broadband Development to identify areas of digital inequity in Minnesota. Through that process it was realized that staff could provide a new service to the community, in particular senior citizens. Workshops and instructional videos are being developed to help seniors with internet, device, and app usage. Individual appointments will also be available for folks who want help with any aspect of internet use from setting up equipment to loading apps to using Facebook. Staff is also looking at ways to fund the new service, such as grants.
- The summer production schedule is underway. It includes the Blaine, Centennial, and Spring Lake Park High School graduations, all city parades, and coverage of the USA Cup Soccer tournament.
- 1<sup>st</sup> quarter Comcast franchise and PEG fees were received. The amounts fell within expectations and funding for the 2023 budget is in good shape.
- North Metro TV staff is working to develop commercial sources of income.
  Currently there are nine different projects underway including drone service
  for the city of Osseo, promo production for a non-profit organization,
  coverage of the Columbia Heights Jamboree Days parade and providing
  streaming and production services for the National Sports Center. Home
  movie transfers saw their single busiest month in May. Several city
  newsletters printed information about the service in the spring and it seems
  to have made a big difference.
- Long-time Administrative Assistant, Rose Valez, retired on June 2<sup>nd</sup> after 24 years of employment with the Commission. Some of her responsibilities have been assumed by current employees. An accounting firm was retained to complete accounting and financial reporting tasks.

# **REPORT OF LEGAL COUNSEL**

- M. Bradley reported on the following items:
  - Encouraged the Commission to read items regarding current federal legislation in the Legal Report.

- Senate File 3039 and House File 3261 were introduced last session. It is a bill that would enhance funding for PEG organizations and municipal digital media.
- It will be important for cities to support federal and state legislation regarding new sources of funding for municipal digital media. As the cable franchise funding source decreases, legislation geared toward transitioning that funding source to broadband based solutions will be essential.
- President Biden has nominated a fifth Commissioner for the FCC.
   Confirmation hearings will be held later in June.

# **OLD BUSINESS**

H. Arnson reviewed and summarized the pay study and recommendations regarding market based pay increases for NMTV staff. The Operations Committee created a new step matrix that reflected the recommended updates by consultant, Dan Tesch. The Committee would like to move each employee to the step above what they are currently earning, as long as it is at least 2% more. The increases would be retroactive to January 1<sup>st</sup>. The cost of that recommendation to the 2023 budget will be \$33,929, which includes salaries and payroll taxes. It was noted that savings of over \$82,000 had been identified in the personnel/benefits areas of the 2023 budget due to staff turn-over and a retirement. Even with the additional cost of an accounting service, in 2023, the amended budget should be \$26,000 lower than the original.

**MOTION:** To adopt and implement the market-based step increases for NMTV staff as recommended by the Operations Committee. **Motion made by D. Love.** Second, C. Massoglia. Motion passed unanimously.

### **NEW BUSINESS**

 It was recommended that the Cable Commission approve amending the 2023 budget to reflect the market based salary increases and costs related to hiring an accounting service.

**MOTION:** To amend the 2023 budget to reflect the market based salary increases and the use of an accounting service. **Motion made by B. Goodboe-Bisschoff. Second, N. Dorner. Motion passed unanimously.** 

H. Arnson presented the draft 2024 NMTC budget. The personnel line items
included recommended market based step increases, with the Executive
Director position being budgeted at the maximum step to provide flexibility in
the hiring process. Other budget increases include a COLA increase of 3%,

recommended step increases, a \$45 per month/per employee increase in the benefits package, building maintenance, insurance, and accounting service lineitems. Capital expenditures include a master router for master control, a tripod and lens for the production truck, cameras and microphones, routine computer and software purchases, a security system upgrade, the HD bond payment and PEG fees for cities. The total 2024 budget is \$29,759 lower than the 2023 budget. If an Executive Director is hired at the minimum salary level the total budget would be \$58,521 lower than the 2023 budget.

MOTION: To approve the 2024 budget as presented. Motion made by D. Love. Massoglia. Second, C. Massoglia. Motion passed unanimously.

In August, a total of **74 new programs** were produced utilizing the North Metro facilities, funds, and services. This constitutes **56:15:00** hours of new programming.


- 29 programs were produced by the public

The HD production truck was utilized for 16:45:00 hours of production in August. The following events were produced live and/or recorded for additional playback:





# **NSPN.TV Streaming Agreement**

North Metro TV has entered into an agreement with the Neighborhood Sports Network (NSPN.TV) to stream fall sports. NSPN.TV holds the contract with the Minnesota State High School League for streaming all high school sporting events. They typically stream games utilizing a single camera and charge viewers a fee for accessing the service. Fees are paid on a monthly or annual subscription basis and NSPN also provides downloads of their games for a fee. NSPN is intereste in streaming games produced by other entities, such as NMTV. In exchange for allowing this, NMTV would receive compensation based on subscription and download levels. This is an income source that North Metro TV has been considering for some time as it fits perfectly into the goal of earning money without changing NMTV's mission. The agreement is for a trial basis that covers the fall sports season. At that point the partnership will be re-evaluated and consideration given as to whether it benefits NMTV to continue.

### **Safety Camp**

Special Events Coordinator, T.J. Tronson, spent a couple of days covering the annual Blaine Safety Camp activities at the SBM fire station #3. Facility Manager, Eric Houston, is ready to start offering our city meetings as podcasts. It is one after distribution method for city information that




# League of Women Voters Friend of League Award

# Senate Confirms Biden Nominee Anna Gomez to Fill Vacant FCC Seat

The United States Senate on Thursday, September 7, confirmed Biden nominee Anna Gomez to serve on the FCC. Gomez was confirmed 55-43. The confirmation vote ends a 2½ year period during which the Commission has been in a 2-2 deadlock of Republican and Democratic commissioners. Gomez is a telecom lawyer who worked at the FCC and also in the private sector. She is currently a communications policy adviser at the State Department. She will be the first Latina to serve on the commission in more than 20 years.

# Commission Files Reply Comments Supporting All-In Cable Pricing Rules

The Commission joined a coalition of cable commissions and local governments in filing reply comments in the FCC's "All-In Pricing" docket in which the FCC proposes to adopt a new rule requiring cable operators and direct broadcast satellite (DBS) providers to specify the "all-in" price for their video programming services on subscribers' bills and in their promotional materials.

The reply focused on three main points:

- 1. Emphasizing the support in the record for the new rules.
- 2. Supporting other commenters who expressed support for the rules, including Consumer Reports suggestion that the Commission consider prohibiting all itemization of "junk fees."
- 3. Rebutting claims by industry commenters that there is no issue with junk fees or confusion on cable bills, and reiterating that the Commission has authority to impose the proposed rule with respect to cable operators.

# Minnesota Office of Broadband Development Releases Draft Digital Opportunity Plan

The Office of Broadband Development has released a draft Digital Opportunity Plan for public input. The Plan outlines how Minnesota will use an upcoming grant from the federal government

to advance digital equity. Each state must submit a plan to the National Telecommunications and Information Administration (NTIA) detailing how it will spend its allocation from the \$2.75 billion Digital Equity Act. A draft of the Digital Opportunity Plan is available <a href="https://mn.gov/deed/programs-services/broadband/adoption/">https://mn.gov/deed/programs-services/broadband/adoption/</a>.

We urge the Commission to work with other cable commissions and local governments to provide comments on the Plan. Our primary message would be that the Digital Opportunity Plan must include a plan to ensure equal access to the same quality of service of broadband throughout every city in the state. The best way of ensuring equal access is municipal franchising, and thus municipal franchising should be included as a recommendation in the Plan. Please let us know if you would like us to participate on your behalf with joint comments.

# Treasury Releases Interim Final Rule Updating ARPA's SLFRF Program to Provide Additional Flexibility

According to a bulletin issued by the National League of Cities, on August 10, 2023, the U.S. Department of Treasury released its Interim Final Rule governing the new uses of the Coronavirus State and Local Fiscal Recovery Funds (SLFRF)authorized by Congress in December 2022, which add three new expenditure categories. The new expenditure categories are:

- Spending to provide emergency relief from natural disasters
- Spending on surface transportation infrastructure eligible projects and matching funds
- Spending on any program, project, or service that would also be eligible under HUD's Community Development Block Grant (CDBG) program

Commentators have noted that the new categories introduce needed flexibility into the use of SLFRF funds. After publication in the Federal Register, there will be a 60-day comment period. The time to proceed to a final rule will depend on the volume and complexity of comments. The full NLC article is available <a href="https://example.com/here/beta/lea/">here/beta/lea/</a>.

# 45 Bipartisan Members of Congress Call for Extension of "Affordable Connectivity Program" for Broadband

On August 17, 2023, a bipartisan group of 45 Members of Congress, wrote to congressional leadership to call for an extension of the federal Affordable Connectivity Program (ACP) in the upcoming government appropriations bill. The ACP provides millions of families with financial assistance intended to ensure every household nationwide has access to high-speed and reliable broadband. Specifically, the program provides eligible households with up to \$30 per month toward their internet bills, and a one-time subsidy of \$100 toward desktops, laptops, or tablet computers for children and families.

# FCC Seeks Comment On Possible Revision of Cable-Related Regulations Under Regulatory Flexibility Act

The FCC, on August 17, 2023, released a Public Notice seeking comment regarding the possible revision or elimination of Commission rules adopted between 2007–2012 that have or will have a significant economic impact on a substantial number of small entities. The Regulatory Flexibility Act requires the Commission to review all such rules to determine whether they should be continued without change, amended, or rescinded, consistent with the stated objectives of applicable statutes, to minimize such economic impact.

The 72 page list of rules under review, attached as an Appendix to the Public Notice, includes rules regarding cable franchising (see Part 76, starting at p. 47), and numerous other sections of the FCC's cable television regulations. There is no indication the Commission intends to change any rules related to cable regulation, however, we will track this docket in the event commenters propose changes. The Public Notice and Appendix, DA 23-710 in CB Docket No. 23-283, can be found <a href="https://example.com/here">here</a>. Comments are due 60 days after publication in the Federal Register.

# FCC Issues FM Digital Power NPRM In MB Docket No. 22-405

On July 31, 2023, the FCC adopted a Notice of Proposed Rulemaking (NPRM) that seeks to give digital FM and Low Power FM stations more flexibility to increase digital power levels. According to the FCC's August 1 Public Notice, available <a href="here">here</a>, this would encourage more FM broadcasters to adopt digital technology and would make digital broadcasts available to a greater number of listeners. The NPRM seeks comment on two proposals and asks whether these changes will benefit the public or impact existing FM services.

Specifically, the NPRM proposes to change the way an FM station can determine its maximum permissible digital power level, thus expanding the number of stations that can broadcast at higher digital power levels. Additionally, it proposes to allow FM stations to operate their digital sidebands at different power levels in order to give broadcasters greater flexibility to maximize power while avoiding interference. According to the Public Notice, these proposed actions would offer more efficient FM digital operation, increase digital signal coverage and provide a more robust digital signal for reception inside buildings.

Comments are due September 21, 2023; Reply Comments are due October 6, 2023.



# Massachusetts Lawmakers Look to Streaming Services to Fund Public Access Media

As local journalism contracts, community stations — which are seeing their own revenue decline — are becoming a key information source for communities

Massachusetts lawmakers are considering legislation that advocates say would make it the first state in the nation to levy fees on streaming companies like Netflix in order to help fund community media.

The "Act to Modernize Funding For Community Media Programming" is proposing a five percent fee on digital streaming providers, based on a company's gross annual revenue in the state. A portion of the fee would be distributed to municipalities for the support of their community media centers — colloquially known as public access television.

The proposed legislation, which is in the early stages of committee review in the state legislature, is aimed at supplementing decreasing cable revenue fees, which make up a large portion of community media budgets.

Under the federal Cable Communications Policy Act of 1984, cable providers currently pay a percentage (up to five percent of gross annual revenue) of their franchise license agreements with municipalities in exchange for using local infrastructure to reach customers. For nearly 40 years, these fees have represented a major source of funding for community access stations across the country that produce non-commercial public, educational, and governmental (PEG) programming. (Disclosure: The author serves as a volunteer member on the board of the non-profit Watertown [Mass.] Cable Access Corp.)

But as consumers increasingly quit cable for streaming entertainment services, a major source of funding for community media is in jeopardy. At the same time, these stations are playing an increasingly vital role in a shrinking local news ecosystem, according to Jonathan Grabowski, the executive director of Marshfield Community Television and a clerk on the board of Mass Access, a nonprofit that advocates for community media.

"In an age of remote participation and a lack of local media coverage, community media centers in Massachusetts have found themselves in the untenable situation of increased demand for services with less funding," Grabowski testified at a July 13 hearing on the bill.

Seventy percent of Mass Access' member organizations reported a sharp increase in coverage of local meetings since 2020, to support hybrid open-public-meeting requirements during the pandemic, Grabowski testified, while nearly 60 percent reported a decrease in funding during the same time period. Citing figures from the Massachusetts Department of Telecommunications and Cable, he added that cable subscriptions have decreased by more than 30 percent in the state from their apex a decade ago, with the largest-ever decrease in subscribers — 10 percent — occurring between 2021 and 2022. At that pace, Grabowski warned, the \$63.3 million in cable franchise fees that go to supporting Massachusetts' community media centers will decrease by more than half by 2030.

The proposed legislation (H.74 and S.34), which has more than 70 cosponsors to date, would direct the state to collect fees from streaming companies twice per year into the general fund. Twenty percent would be retained for administrative costs, and the remaining 80 percent would be disbursed to municipalities, based on population, to be evenly split between the municipality and its community media station for "expenditures related to hybrid municipal meetings, data infrastructure improvements, somol technology programs and more,"

according to Mass Access.

At least a dozen states currently levy some kind of digital tax on streaming services, but Massachusetts would be the first state to earmark a portion of the fees specifically to support community media, according to David Gauthier, the president of Mass Access and the executive director of Winchester Community Access & Media. Massachusetts is leading the legislative push, according to Gauthier, because it is home to more than 200 — or 13 percent — of all the community media centers in the nation. According to Mass Access, Massachusetts, with a population of around 7 million people, has more stations than California and Texas, the only other two states to have more than 100 community media centers.

Sponsors of the bill estimate it could generate about \$65 million annually, which would replace, not add to, the projected decline in cable fees, according to Gauthier. Netflix and other streaming services did not return a request for comment. But several people representing the interests of cable, satellite, and streaming service providers testified at the legislative hearing that any additional fees on streamers would translate to a new tax on consumers at a time when many are eschewing cable for streaming in an effort to save money.

Tim Wilkerson, president of the New England Connectivity and Telecommunications Association (NECTA), a nonprofit trade association that represents several internet, broadband, cable, television, and content providers, said Massachusetts would go from being "the envy of most states" for having "the right regulatory environment for industry to invest, innovate, and partner with state government," to damaging that reputation were it to levy fees on streaming companies.

During testimony before the Joint Committee on Advanced Internet Technology, the Internet, and Cyber Security, which included the streaming bill and other initiatives, Wilkerson urged the committee not to change the current regulatory environment. "Today, there are several well-intended bills before you that would reverse that proven policy of predictability by proposing regulatory expansion that is unnecessary, would be costly for consumers and industry, and in some instances, likely preempted by federal law," he said.

Chris Gilrein, the executive director of Massachusetts and the Northeast for TechNet, a national network of technology CEOs and senior executives that "promotes the growth of the innovation economy," also claimed the proposed legislation would mean higher fees for consumers.

"Beyond being an ill-timed burden on your constituents, this new tax would be duplicative and administratively cumbersome and sending a negative message to innovators and early adopters," Gilrein said.

Gauthier of Mass Access, in an interview before the hearing, argued there is nothing in the proposed legislation that would require companies to pass the fees onto consumers.

"We can either throw everything back on the residents, or we can ask these multi-billion-dollar corporations to do their part," Gauthier said, adding he thinks the term "cord cutting" is a misnomer.

"The streaming services are using the same infrastructure [as the cable companies]. The cord remains, regardless of what data runs through it," Gauthier said. "People still have a cord coming into their house. That cable is still running over public lands, and to me, it's the same form of transmission."

Julie Thompson, chief communications officer for business and government affairs at Plymouth Area Community Access Television, testified that despite the declining revenue picture, her station has increased its coverage as a result of more demand for its content. The station has covered more than 966 board and committee meetings and more than 900 informational stories, profiles pieces, sporting events, concerts, parades, and community events over the last 18 months, Thompson testified during the hearing.

"With the demise of local newspapers and the questionable fact-checking of many social media sites, providing a local, trusted source for news and information is our continued mission and goal," Thompson said.

"Everyone wants transparency in government," she added. "Transparency costs money to provide."

NECTA president Tim Wilkerson did not testify on H.74 and S.34 specifically, but on broadband issues at large.

# Finally There Are Five: Gomez Confirmed as FCC Commissioner

More than halfway through President Biden's four-year term as president, the FCC finally has a full complement of commissioners. The Senate today confirmed Anna Gomez for the fifth spot on the commission, which has been largely deadlocked since Biden took office.

Gomez was Biden's second choice to fill the vacant spot when former FCC Chair Ajit Pai left with the change in administration. Biden's initial nominee Gigi Sohn faced strong opposition for over a year before withdrawing herself from the running in March.

In May, Biden <u>nominated</u> Gomez, who faced less opposition. Gomez is a veteran of both the FCC and NTIA. Most recently, she was a senior advisor for International Information and Communications Policy in the State Department's Bureau of Cyberspace and Digital Policy.

Traditionally the political party that holds the White House has the majority on the commission, enabling the commission to advance that party's objectives. No more than three commissioners can be nominees from the same party. Since Biden took office, there have been two Democratic nominees and two Republican nominees on the commission. As a result, no controversial actions have been taken by the FCC.

"Anna brings with her a wealth of telecommunications experience, a substantial record of public service, and a history of working to ensure the United States stays on the cutting edge of keeping us all connected," said FCC Chair Jessica Rosenworcel in a <u>prepared statement</u>.

"Her international expertise will be a real asset to the agency. I look forward to working with her to advance the agency's mission to ensure the benefits of modern communications reach everyone, everywhere and that the United States can continue to lead in the digital age."

# **Industry Reaction**

Many stakeholders within the telecom industry have been arguing that a fifth commissioner is needed so that important decisions can be made. Unsurprisingly, numerous telecom associations issued statements congratulating Gomez on her achievement, while also referencing their own hot button policy objectives.

Here are just a few of the statements that were issued today.

"NTCA and its hundreds of community-based members are eager to work with [Gomez] in her new role to advance the FCC's mission of universal service for all Americans," said Shirley Bloomfield, CEO of NTCA—The Rural Broadband Association.

"The broadband community remains committed to working with her and the Commission toward our shared goal of building our connected future as quickly and efficiently as possible," said Jonathan Spalter, president & CEO of <u>USTelecom – The Broadband Association</u>.

According to <u>ACA Connects</u> President and CEO Grant Spellmeyer, Gomez "has demonstrated her expertise, leadership, and sound decision making."

He added that "We look forward to working with her as the FCC seeks to close the broadband availability and adoption gaps, and to ensure that our small and rural member companies continue to operate in a regulatory environment that enables their enormous investment in reliable, robust broadband infrastructure to meet the needs of consumers."

Matt Mandel, vice president of government affairs at <u>WISPA – Broadband Without Boundaries</u>, said Gomezhas "years of experience and immense talents [that] have commanded universal respect from the telecom and consumer communities, and we are excited to begin working with her on the weighty communications matters of today and tomorrow."

<u>CTIA</u> President and CEO Meredith Attwell Baker noted that Gomez has had "an exceptional public service career, underpinned by a keen understanding of policy and regulatory landscapes."

Baker added that "Her proven track record in government oversight of spectrum management will be invaluable to ensuring America's continued wireless leadership and expanding broadband access for all Americans. We look forward to working with the Commission to get much-needed licensed spectrum to market so we can fuel the next wave of 5G innovation, meet growing data demands and secure the future of America's economy."

Michael Powell, President & CEO, <u>NCTA – The Internet & Television Association</u>, said Gomez "has earned a reputation for being thoughtful about policy and addressing issues with an open mind" and that NCTA is ready to work with her on "the most important issue of the day – bringing high-speed internet to all."



# **Preempting Local Government**

5 Comments

In May the House Energy and Commerce Committee marked up nineteen pieces of telecom-related legislation, which means the bills can move forward to the full House for a vote. Today's blog looks at one bill in particular because it represents what I'm seeing as a new trend of actions taken by big ISPs to preempt the authority of local governments.



The bill is H.R. 3557, the American


Broadband Deployment Act of 2023. This legislation would preempt a host of current rights of local governments to manage public rights-of-way for telecom infrastructure. This applies to both wireless infrastructure like towers, but also to landline infrastructure like fiber, huts, and cabinets

The legislation includes a long list of changes aimed at taking local government out of the business of controlling telecom infrastructure deployment.

- The bill establishes a 60-day shot clock for local governments to consider requests for rightsof-way. If the local government doesn't approve a request within that time, the request is
  'deemed' to be approved. Further, once a project is deemed to be approved, the carrier or
  ISP can proceed with construction without further notice to the local government. It appears
  that would give builders the ability to bypass local inspections, traffic control regulations,
  etc.
- The legislation would give ISPs and carriers the ability to install facilities anywhere they
  choose and bypass local zoning rules. This would also eliminate local requirements to hide,
  conceal, or disguise infrastructure in historic neighborhoods.
- The legislation imposes a complicated formula for calculating and justifying any fees, with the overall goal of greatly lowering fees.
- One of the most intrusive changes is that the legislation would place all disputes at the FCC
  rather than in local courts. This would force local governments to battle disputes in D.C.
  rather than locally. This would upset a 35-year long truce between Congress and local
  governments that allows disputes on local-related issues to be heard in local courts.
- Eliminates cable franchise renewals and eliminates the ability of local governments to require rules such as an ISP having to serve the whole community, the local government

requiring PEG channels, or the local government requiring customer service standards.

The biggest killer is that the law would give holders of franchise agreements the ability to
cancel the agreement without losing any rights-of-ways included in the agreement. This
would also kill local franchise fees, a major source of revenue for many governments.
Perhaps the most severe provision is that franchise contract holders can eliminate any
contract provisions they deem to be commercially infeasible.

There is a mountain of bills in the House this year, and there is no way to know the chances of this coming for a vote. However, there are several telecom bills that have bipartisan support, and bills like this one could be attached to such bills. This includes a bill that would renew the FCC's authority to hold spectrum auctions and a bill that would stop federal grant funding for broadband infrastructure from being taxable.

To me, this bill is part of an ongoing effort of cellular carriers, cable companies, and big telcos to restrict the ability of local governments to affect the construction of infrastructure. These big companies have already been successful in recent years in eliminating regulation. The cellular companies already got relief from the Ajit Pai FCC that made it a lot easier to place cell sites. This law would codify that change so that a future FCC can't change it. The large ISPs were successful in getting the Ajit Pai FCC to eliminate most broadband regulations.

This bill is going for a home run to eliminate local regulations these big companies don't like. I've written recently about regulatory capture, and this is an ultimate example of changing the laws to get what the big monopoly providers want. This law would eliminate franchise fees, allow carriers to put infrastructure anywhere they want, and pay low fees in doing so.

More proof of the degree of regulatory capture in the telecom market is that there are no equivalent efforts to change local government control of other kinds of infrastructure like roads, factories, buildings, etc. This bill is the ultimate example of the biggest companies in telecom flexing their power and influence to bypass some of the last vestiges of regulation.

# Streaming services now cost more than cable TV

# Netflix and Disney Plus subscriptions have risen in price by more than 50 per cent over the last year

Streaming bundles have risen in price above cable TV packages in the US for the first time

The combined cost of popular <u>streaming</u> services like <u>Netflix</u> and Disney Plus is now more expensive than traditional cable television, according to new analysis.

Recent price rises to all of the main streaming platforms for ad-free subscriptions have pushed the cost above the average cable TV package of \$83 per month for the first time.

Calculations by the *Financial Times* found that a bundle of the top US streaming services – including Disney+, Hulu, Netflix and Peacock – rose in price from \$73 to \$87 over the last year.

Some of the price rises of streaming services have been considerable, going way above the rate of inflation.

Netflix raised the price of its basic advertisement-free monthly subscription from \$9.99 to \$15.49, representing a 55 per cent increase.

Disney Plus saw an even bigger increase for its ad-free subscription price, nearly doubling from \$7.99 per month to \$13.99.

"From a business point of view, streaming was going to have to move in this way – the price point was going to have to go up," David Rogers, a professor at Columbia Business School and expert in digital business, told the <u>FT</u>.

"This was accelerated by the fact that we no longer have cheap debt to flood the market with streaming content."

These rising costs, combined with an increasingly fractured streaming ecosystem, have helped contribute to a major surge in online <u>piracy</u> over the last year.

Figures published earlier this year by research firm Muso revealed that the most popular form of piracy is websites that host free streams of films and TV series, which account for 80 per cent of all illegal content consumption.

Visits to these sites rose by nearly 9 per cent last year, with early data suggesting that this trend will continue into 2023.
